# Innovations4Flooring and Classen extend strategic partnership Innovations4Flooring 与 Classen 进一步拓展战略合作关系

- I4F obtains exclusive sub-licensing rights for specific Classen IP portfolio

DOMOTEX, HANNOVER, GERMANY – Innovations4Flooring (I4F), a technology company providing flooring solutions, today announced an extension to its strategic partnership with the Classen Group. With immediate effect, I4F obtains exclusive sub-licensing rights for one of Classen's IP portfolios, comprising over five hundred patents, covering key flooring materials, specific locking patents as well as important inventions for digital printing and liquid laminate technology (LLT). This extended partnership follows the agreement between I4F and the Classen Group announced in January 2017.
